7. Location of service facilities around Pakistan.
8. Financial Position (Bank Statements/Audited Balance Sheet of last 03 years). If available
9. ISO Certification.
10. Income – tax registration/ copy of NTN Certificate
11. Affidavit that the bidder is not blacklisted by any government/semi-govt department.
12. Pre-qualification Document of PASDEC duly signed and stamped.

#### **METHOD OF SUBMISSION OF PROPOSALS**

1. The proposal must be submitted in form of booklet along with supporting documents.
2. Proposal deficient by any of the required document shall not be entertained.
3. Proposal must be sealed and marked as **“Pre-qualification of suppliers for Repair & Maintenance/Replacement of Parts {Loader, Excavator, Dump Truck and Low Bed Truck}”**.
4. PASDEC reserves right to verify details of the bidders and to inspect their facilities.
