

**INVITATION TO BID
BID DOCUMENT
REPAIR /REPLACEMENT OF PARTS for Hyundai Excavator 450 LC-7A**

Pakistan Stone Development Company [PASDEC] incorporated under section 42 of Companies Act, 2017 working under Ministry of Industries and Production. PASDEC works for development of Marble and Granite sector of the Country. PASDEC invites sealed bids under Single-Stage-Two-Envelopes procedure for Repair/Replacement of Parts for Excavator 450 LC-7A (Hyundai), located at Risalpur.

METHOD OF SUBMISSION OF BID:

1. Bids must be submitted under a proper cover letter mentioning important points/enclosures.
2. Bids should be submitted under Single-Stage-Two-Envelopes procedure in a sealed package comprising three separate, duly sealed envelopes, comprising: Technical Proposal, Financial Proposal and Bid Security. The envelopes must be clearly marked on the top as “Technical” or “Financial Proposal” or “Bid Security for [name of Package]”
3. Bid deficient by any of the required document shall not be entertained.
4. Bids must accompany bid security **[as required for each package]** in shape of DD/PO/CDR, valid for 120 days.
5. Bid must be sealed and marked as **““Bid for Repair and Replacement of Parts Hyundai Excavator 450LC -7A”** should reach by latest by 10:30 am of **16th May 2019**. The bids shall be opened at **11:00am** on the same day in presence of bidders who wish to attend the bid-opening-session.
6. PASDEC reserves right to verify details of the bidders and to inspect their facilities.

Evaluation Criteria: Techno-Financial Evaluation {60:40} of qualifying firm will be conducted by PASDEC as per following parameters.

Affidavit that the bidder is not blacklisted by any government/semi-govt department.	5 marks
Financial Evaluation [40 marks]	
Quoted Price [Inclusive of all taxes] for Package - A or Package – B	40 marks

Evaluation will be made in the manner that 60% weight is allocated for technical parameters and 30% weight is allocated for quoted bid price [inclusive of all taxes]. Assessment of the Total Weight (Technical Weight + Financial Weight) will be standard.
